HOUSE ORDER FOR THE GUESTS WITH TENT, CARAVAN AND RV

The checking in into the campsite supposes that our guests learned our house order and accept it as mandatory for themselves.

Check-in Check-out

in pre-season /post-season

arriving between 7.00 - 22.00 departure until 18.00, it is possible to pay until 18.00

in high season (July-August)

arriving between 13.00 – 22.00 departure until 12.00 it is possible to pay until 10.00

- Upon arrival the guests should check in at the reception.
- The wrist-band (placed around the arm) is for the certain person, it can't be transferred, it shall be worn accordingly. It should be presented when entering or exiting the campsite, and it shall be checked by the barcode reader when entering the spa area.
- The eventual changes shall be reported immediately (e.g. earlier departure, change of plot, etc).
- If on the previously announced day of departure the guest remains in the campsite beyond the abovementioned departure time, we are charging an extra fee equalling the amount that corresponds to the cost of an entire day.
- In case of plotted area only the plot can be occupied. No other area can be used besides the
 designated area, not even temporarily, the guest's car shall remain within the guest's own designated
 plot.
- Please do not disturb the other guests between 13.00 and 14.00 respectively between 22.00 and 6.00.
- In the interest of the other guests we are not accepting new guests between 22.00 and 7.00 in the
 morning and there is no vehicle-traffic. In this period no activity can be performed that would disturb
 others.
- In the campsite area and the community facilities can be used by the minor children accompanied by their parents or relatives, the parents or the accompanying people shall be held liable for their behaviour.
- No foreign people can enter the campsite, the visitors can ask for entry at the reception.
- The valuables and documents can be left at the reception for safekeeping, otherwise we do not assume liability for them.

- Please do not use the social buildings during the cleaning period!
- The sewage containers of the Recreation vehicles / caravans can be emptied into the chemical WC built for this purpose.
- It is forbidden to wash your vehicle in the camping area!
- Please do not perform commercial activity within the camping area!
- Within the camping area the dogs should be on leash! Due to the strict regulation the dogs can't be taken into the water block or community cooking area. Every dog owner is responsible for the personal- and material-related damages.
- The information and detailed fire-protection house order related to extraordinary events can be found at the reception.
- The pre-occupation of the tent and caravan / RV plots is not active in July / August.

FIRE PROTECTION REGULATION

- It is not permitted to perform activities within the camping area that may cause fire or explosion.
- It is not allowed to leave the open-flame or electric cooking-frying equipment unattended when being in use. In case of danger, strong heavy, rain or if it is not needed any longer, the fire shall be put out or the equipment needs to be turned off!
- During the utilisation of the cooking-frying equipment it is strictly <u>PROHIBITED</u> to use explosion- or fire-hazardous boosters (gasoline, gas, paint-diluter, etc.) to lit or quicken the fire!
- In the camping area it is prohibited to use electric equipment that is not standard, or it is fire- and accident hazardous. Only those electric equipment items can be used that are in impeccable technical condition, are mounted properly and can be connected (fireplace, refrigerator, air condition, lighting tools, etc.)
- When leaving the rented area the electrically operated equipment shall be disconnected and switched
 off, the electric equipment that is not used for a longer period, need to be disconnected from the
 electric system. This does not relate to the devices that are designed for on-going functioning
 (refrigerator).
- From one socket only one unit can be operated, it is NOT PERMITTED to use distributors!
- In case of using an extension cord it is not permitted to use another extension from the first one. The maximum length of the extension cord is 3 meters.
- Only the plugs corresponding to the Hungarian standards can be used.
